FINAL DEFAULT JUDGMENT

THIS CAUSE came before the Court on Plaintiff's Motion for Entry of Default Final Judgment, and the Court having reviewed the Court reviewed the file and all relevant papers, having considered the motion, having determined that default was properly entered against Defendant, AUDIO VIDEO POWER SUPPLIES CORP, and being otherwise duly advised on the premises it is hereby:

ORDERED AND ADJUDGED as follows:

1. Defendant AUDIO VIDEO POWER SUPPLIES CORP, is permanently enjoined from, directly or indirectly using of any mark, trade name, label or form of advertisement the same or similar to "PurePower" or any other mark which creates customer confusion resulting from Defendants' false and deceptive advertising and use of a deceptively similar mark. Defendant AUDIO VIDEO POWER SUPPLIES CORP. is further directed to shut down the internet website www.purepoweravps.com, to the extent it has not done so already, and is directed to refrain from creating any website the same or similar to Plaintiff's website www.purepoweraps.com or any website that utilizes any mark, trade name, label or form of advertisement the same or similar to "PurePower" or which creates customer confusion.

2. Plaintiff, PUREPOWER PARTNERS, LLC, whose address is 148 Northumberland Street, Unit 4, Ayr, Ontario NOB 1E0, shall recover from Defendant, AUDIO VIDEO POWER SUPPLIES CORP, whose address is 3422 Old Capitol Trail, Suite 700, Wilmington, DE 19808, damages in the amount of SIX HUNDRED FORTY-NINE THOUSAND ONE HUNDRED THIRTEEN AND 00/100 DOLLARS (\$649,113.00) that shall bear interest at the statutory rate as provided by Florida Statutes, for which sum let execution issue forthwith.

3. Defendant, AUDIO VIDEO POWER SUPPLIES CORP., shall furnish Plaintiff's attorney, Joseph P. Kenny, Esquire, of Weber, Crabb & Wein, P.A., 5999 Central Avenue, Suite 203, St. Petersburg, Florida 33710, with a Fact Information Sheet in Form 1.977 within 45 days of this date and file a notice of compliance with the Clerk of this Court as required by Rule 1.560.
